#### INTRODUCTION

The Department of Veterinary Sciences of Torino announces n. 1 research scholarship for 5 months, pursuant to art. 1 letter A of the "Regulations for the establishment of research scholarships" of the University of Turin.

The amount of the scholarship is € 5,665.00 in total (five thousand six hundred and sixty five) tax included and is paid in monthly installments in arrears. The responsible of the funds is Prof Mario Baratta.

The scholarship, aimed at encouraging the scholarship holder to carry out a research activity, is destined to carry out research activities within the project entitled "Analysis of data collection and management of communication activities for the Ecolamb project", the activity is carried out within the network of the European project and foresees the permanence within the research units, not only the leading one of the coordination, of which the Head of the Veterinary Sciences is led.

The research activity will consist of:

- maintenance and constant updating of the multilingual website
- Elaboration and publication of a multilingual brochure on the results of the project to be made available to the key players in the sector throughout the supply chain, from farmers to consumers, as well as from policy makers, consultants and educators.
- Preparation of technical sheets, brochures, posters and other dissemination tools to assist actors with transnational knowledge.

The beginning of the activities is established, according to the needs of the structure and research, by the Scientific Responsible in agreement with the Director of the Department and with the scholarship holder.

#### APPLICATION PROCEDURE AND DEADLINES

Application forms must be filled out and submitted by **27th September 2019, 12:00 a.m. Centrale European Summer time.**

Application forms have to be filled and submitted in one of the ways reported below:

In order to complete the application procedure, candidates must attach:

- a Europass Curriculum Vitae (link europass: <https://europass.cedefop.europa.eu/>);
- A copy of a valid ID or passport.

The scholarship is proposed for Italian and foreign citizens in possession of: Master Degree Animal Science, Biological Sciences or equivalent qualifications to the aforementioned degrees pursuant to law, or an equivalent qualification issued by foreign universities.

In this last case, if the candidates do not already possess the "Declaration of equivalence" issued by the MIUR, they must request it from the Selection Committee, which can express themselves only for the purpose of using the scholarship.

Candidates must have certified experience in the analysis of ecosystems integrated in the production of farm animals, experience of communication in English ability to manage reports of international research projects, experiences of evaluation of animal welfare.

Participation in this procedure is precluded to those who have a degree of kinship or affinity, up to and including the fourth degree, with a professor or researcher belonging to the Department, or with the Rector, the General Manager or a member of the Council of Administration of the University.

## **EVALUATION PROCEDURES AND NOMINATION**

The selection for awarding the scholarship is based on qualifications, curriculum and interview.

The Commission has 100 points to be divided into 70 points for the evaluation of qualifications and 30 points for the oral test.

Within these limits, the Commission establishes the criteria for the allocation of points to the qualifications and the interview, as well as the possible minimum score for admission to the oral exam.

In any case, the Commission must assign a score to the PhD degree or equivalent qualification obtained abroad and, for the sectors concerned, to the specialization title in the medical area.

The interview is aimed at ascertaining the knowledge concerning the research subject of the scholarship and the knowledge of the English language.

The oral exam will take place on 2<sup>nd</sup> October 2019 at 14:00 p.m. at the Meeting Room of Veterinary Physiology Dept. ground floor red building of the Department of Veterinary Sciences, Largo Braccini 2, Grugliasco (TO).

The oral exam can also be supported via skype at the request of the candidate.

Applications will be evaluated by specific Department Commission according to the criteria stated below.

Applicants may be also interviewed using long-distance audio and video systems (via Skype), on condition that their identity can be checked.

The list of eligible candidates and their scores will be published on the Department website (<http://www.disafa.unito.it>).

One candidate will be chosen for the proposed fellowship, eligible for this call.

## **FELLOWSHIP ARRANGEMENTS**

Fellowships positions will be formalized through fellowship grants. To such grants no taxes will be applied.

Appointed fellows are requested to inform [compensi.agrovet@unito.it](mailto:compensi.agrovet@unito.it) whether they are able to accept the fellowship within 10 days from the sending of the selection confirmation.

The Department will then formally process the fellowship grant. The grant will have to be signed by the fellow either before the beginning or on the first day of the research period.

In case of non-acceptance, the fellowship will be awarded to the next candidate in the list of eligible candidates.

Upon signature of the fellowship, the candidate will acquire the status of fellow for the whole period of activity.

## **GRANT EXPENSES**

The appointed fellow will receive a five-month grant of 5.665,00 €. The fellowship will be paid in deferred monthly installments. The amount reported is a net income.

The fellowship does not give rights to unemployment allowance or pension benefits.

## **INSURANCE**

The University of Torino provides a comprehensive insurance plan for the fellows during their research activities.

## **RIGHTS AND DUTIES OF THE FELLOW**

Appointed fellows have full access to research facilities offered by the Department. They have to follow rules and safety standards of the University of Torino.

At the end of the fellowship, the fellow has to submit a scientific report of his/her activities.

The report has to be validated by the scientific responsible and has to be sent within one month after the end of the fellowship by e-mail at [compensi.agrovet@unito.it](mailto:compensi.agrovet@unito.it)

The results of research carried out by the fellow are the exclusive property of the University. Publication and dissemination of these results have to be approved by the University.

## **DATA PROTECTION**
